

PLANNED GIVING GUIDE

You can name Westmark School in your long-range plans, including:

- o IRA or retirement plan
- o Life insurance policy
- o Financial account
- o Charitable IRA distribution: If you are age 70-1/2 or older, you may be eligible to transfer up to \$100,000 in gifts directly from your IRA to Westmark School and exclude the amount of your gift from taxable income.

SUGGESTIONS FOR BEQUEST VERBIAGE

You may include a bequest to support Westmark School when preparing your will or living trust, or by adding a codicil to your present will or living trust. Bequests may be of cash, securities, bonds, real estate, copyrights, royalties, or other property. Bequests of all sizes are welcome, whether they are outright, residual, or contingent.
